# **Offsite Dirt Privacy Policy**

## Introduction

Offsite Dirt ("Offsite Dirt" or "We" or "Us" or "Our") respects your privacy and is committed to protecting it through our compliance with this policy.

This policy describes the types of information we may collect from you or that you may provide when you visit the website https://offsitedirt.com/ or engage with the Offsite Dirt mobile application ("App") (collectively, our "Services") and our practices for collecting, using, maintaining, protecting, and disclosing that information.

This policy applies to information we collect:

On this website.

Through the App.

In email, text, and other electronic messages between you and these Services.

It does not apply to information collected by:

Us offline or through any other means, including on any other website operated by Offsite Dirt or any third party (including our affiliates and subsidiaries); or

Any third party (including our affiliates and subsidiaries), including through any application or content (including advertising) that may link to or be accessible from or on the Services.

Please read this policy carefully to understand our policies and practices regarding your information and how we will treat it. If you do not agree with our policies and practices, your choice is not to use our Services. By accessing or using the Services, you agree to this privacy policy. This policy may change from time to time (*see* Changes to Our Privacy Policy). Your continued use of these Services after we make changes is deemed to be acceptance of those changes, so please check the policy periodically for updates.

#### Information We Collect About You and How We Collect It

We collect several types of information from and about users of our Services, including information:

By which you may be personally identified, such as telephone number ("personal information");

That is about you but individually does not identify you, including protected classification characteristics such as gender, age, household income, and marital status, commercial information such as records of products, product types, merchants, merchant types, and goods or services purchases, obtained, or considered by you;

About customer record information, such as payment account name, payment account number, payment card expiration date, and billing address;

About sensory data such as audio recordings of your voice, if provided directly to Offsite Dirt;

About geolocation data derived from your device such as locale preferences for your use of the Services; and

About your internet connection, the equipment you use to access our Services, and usage details.

We collect this information:

Directly from you when you provide it to us.

Automatically as you navigate through the site. Information collected automatically may include usage details, IP addresses, and information collected through cookies.

From third parties, for example, our business partners.

Information You Provide to Us

The information we collect on or through our Services may include:

Information that you provide by filling in forms through our Services. This includes information provided at the time of registering to use our Services, subscribing to our service, or requesting further services. We may also ask you for information when you report a problem with our Services.

Records and copies of your correspondence (including email addresses), if you contact us.

Your search queries on the Services.

Information We Collect Through Automatic Data Collection Technologies

As you navigate through and interact with our Services, we may use automatic data collection technologies to collect certain information about your equipment, browsing actions, and patterns, including:

Details of your visits to our Services, including traffic data, location data, logs, and other communication data and the resources that you access and use on the Services.

Information about your computer and internet connection, including your IP address, operating system, and browser type.

The information we collect automatically is only statistical data and does not include personal information, but we may maintain it or associate it with personal information we collect in other ways or receive from third parties. It helps us to improve our Services and to deliver a better and more personalised service, including by enabling us to:

Estimate our audience size and usage patterns.

Store information about your preferences, allowing us to customise our Services according to your individual interests.

Speed up your searches.

Recognise you when you return to our Services.

The technologies we use for this automatic data collection may include:

**Cookies (or browser cookies).** A cookie is a small file placed on the hard drive of your computer. You may refuse to accept browser cookies by activating the appropriate setting on your browser. However, if you select this setting you may be unable to access certain parts of our Services. Unless you have adjusted your browser setting so that it will refuse

cookies, our system will issue cookies when you direct your browser to our Services.

**Web Beacons:** Pages of our Services may contain small electronic files known as web beacons (also referred to as clear gifs, pixel tags, and single-pixel gifs) that permit Offsite Dirt, for example, to count users who have visited those pages and for other related website statistics (for example, recording the popularity of certain website content and verifying system and server integrity).

### **Third-Party Use of Cookies**

We use information that we collect about you or that you provide to us, including any personal information:

To notify you about changes to our Services or any products or services we offer or provide though it.

In any other way we may describe when you provide the information.

For any other purpose with your consent.

## **Disclosure of Your Information**

We may disclose personal information that we collect or you provide as described in this privacy policy:

To our subsidiaries and affiliates.

To contractors, service providers, and other third parties we use to support our business.

To a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of Offsite Dirt's assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in

which personal information held by Offsite Dirt about our Services users is among the assets transferred.

To fulfil the purpose for which you provide it.

For any other purpose disclosed by us when you provide the information.

With your consent.

We may also disclose your personal information:

To comply with any court order, law, or legal process, including to respond to any government or regulatory request.

To enforce or apply our Website Terms of Use, Mobile App End User License Agreement, and other agreements, including for billing and collection purposes.

If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of Offsite Dirt, our customers, or others.

## **Choices About How We Use and Disclose Your Information**

We strive to provide you with choices regarding the personal information you provide to us. We have created mechanisms to provide you with the following control over your information:

**Tracking Technologies and Advertising.** You can set your browser to refuse all or some browser cookies, or to alert you when cookies are being sent.

We do not control third parties' collection or use of your information to serve interest-based advertising.
